## 2. College at a Glance

The college has emerged as a prominent centre of higher learning, catering especially to the educational aspirations of students from rural areas of Himachal Pradesh. Affiliated to Himachal Pradesh University, the college offers quality undergraduate education in the streams of Arts and Commerce under the RUSA (CBCS) framework and NEP 2020. As a co-educational institution, the college takes pride in its dedicated team of highly qualified, dynamic, experienced and committed faculty members who continuously strive for academic excellence and holistic student development.

Despite being a relatively small institution, the college has earned recognition for its academic achievements, intellectual vitality, and student-centric environment. ## 7. An Overview of National Education Policy (NEP) 2020

The National Education Policy (NEP) 2020 introduced by the Government of India aims to make education holistic, flexible, multidisciplinary, skill-oriented, and learner-centered. In accordance with the guidelines issued by the Government of Himachal Pradesh and Himachal Pradesh University, Government Degree College Subathu shall implement the provisions of NEP-2020 from the current academic session. The policy focuses on academic excellence along with skill development, critical thinking, ethics, communication skills and overall personality development of students.

Under NEP-2020, the college will follow a Three-Year Undergraduate Degree Programme under the semester system consisting of six semesters. The system includes classroom teaching, assignments, seminars, projects, practical work, internal assessment and end-semester examinations. Students will also be encouraged to participate in internships, workshops,

community engagement programmes, and co-curricular activities to enhance employability, leadership qualities, social responsibility, and practical learning.

### **National Education Policy (NEP)-2020 B.A. 1 Arts**

Government Degree College Subathu offers the Bachelor of Arts (B.A.) Programme under the framework of NEP-2020 as prescribed by Himachal Pradesh University. The programme follows the semester system and is designed to provide holistic, multidisciplinary, and skill-oriented education. The B.A. Programme is of three years' duration divided into six semesters. It focuses on academic learning, critical thinking, communication skills, ethical values, personality development and employability. Under NEP-2020, students study Major, Minor, Ability Enhancement, Skill Enhancement and Value-Added Courses.

The college presently offers the following subjects:

- English
- Hindi
- History
- Political Science
- Economics

### **Multiple Entry and Multiple Exit (MEME) System**

The undergraduate programme under NEP-2020 is designed to provide flexibility to students in terms of duration, subject choices, and academic progression. Students may complete the programme at different stages and receive appropriate certification as per the duration of study completed successfully. However, at present, the B.A. Degree Programme offered by the college shall ordinarily be of **three years duration comprising six semesters**. The programme follows the semester system and continuous evaluation pattern as prescribed by the university.

❖ **Discipline Specific Core Courses (DSC)**

Discipline Specific Core Courses are compulsory courses of the major subject that provide students with fundamental and advanced knowledge of the discipline. These courses form the academic foundation of the programme and are designed to develop critical understanding, analytical ability, subject knowledge, and theoretical competence in the chosen field of study

❖ **Discipline Specific Elective Courses (DSE)**

Discipline Specific Elective Courses are specialized courses offered within the major discipline. These courses allow students to explore specific areas of interest and gain deeper knowledge according to their academic preferences and career aspirations.

❖ **Minor Courses (MC)**

Minor Courses are offered from a discipline other than the student's major subject to encourage multidisciplinary learning and broaden academic exposure. These courses help students acquire basic knowledge and understanding of another field, enhancing flexibility and interdisciplinary competence.

❖ **Multidisciplinary Courses (MDC)**

Multidisciplinary Courses are designed to promote holistic and interdisciplinary education by integrating knowledge from different disciplines. These courses enhance intellectual breadth, creativity, critical thinking, and the ability to understand diverse perspectives.

❖ **Skill Enhancement Courses (SEC)**

Skill Enhancement Courses focus on developing practical, professional, and employability-oriented skills. These courses are intended to improve communication, technical abilities, creativity, problem-solving and other competencies required for professional and personal growth.

❖ **Ability Enhancement Courses (AEC)**

Ability Enhancement Courses are aimed at strengthening students' language proficiency, communication skills and functional abilities. These courses help students improve reading, writing, speaking, comprehension and effective communication required for academic, professional, and social interaction.

❖ **Value Added Courses (VAC)**

Value Added Courses are designed to promote ethical values, cultural awareness, environmental consciousness, personality development, and social responsibility. These courses contribute to the holistic development of students beyond the core academic curriculum.

**Internship / Project / Community Outreach**

Internship, project work, apprenticeship, and community outreach activities are integral components of experiential learning under NEP. These activities provide students with practical exposure, field experience, research orientation, professional skills and opportunities for community engagement and social learning.

**Evaluation System Under NEP 2020**

Under the National Education Policy 2020, Himachal Pradesh University follows a semester-based evaluation system under the Choice Based Credit System (CBCS). The evaluation process is designed to assess students through continuous internal assessment and end-semester examinations. The evaluation of each course consists of:

- **Continuous Internal Assessment (CIA):** Includes assignments, class tests, seminars, presentations, attendance, practical work, field work, and viva voce.
- **End Semester Examination (ESE):**  
Conducted by the University at the end of each semester

## 10. Admission Procedure 2026-2027(Online Admission)

- The admission form, complete in all respect, along with copies of required documents to be uploaded, is to be submitted through the college website: <https://gdsubathu.in>.
- Candidate failing to attend counseling or deposit the fee on the day of counseling will lose
- his/her claim on the seat and the seat will be provided to the next candidate in the merit list.
- Admission to 2nd and 3rd Year of the degree course will be done on roll on basis. Students can apply online from the college website and submit the printout of the admission form alongwith mark sheet/admit card/fee receipt of previous class in the office.

### Step to Create Academic Bank of Credit (ABC) ID

## **12. Choice Based Credit System (CBCS) for Old Students of II & III Year**

The old students of 2nd and 3rd Year will also continue under the Choice Based Credit System (CBCS) introduced by Himachal Pradesh University from the academic session 2016–2017 as per the guidelines of the University Grants Commission. The CBCS framework has been adopted to maintain uniformity in the standards of higher education and to provide students with quality education comparable to national standards.

Under this system, the examination and evaluation process is based on the Cumulative Grade Point Average (CGPA). The system follows an annual pattern, and students are required to choose their stream from Arts or Commerce. The curriculum consists of different categories of courses such as Core Courses (CC), Discipline Specific Elective (DSE) Courses, Ability Enhancement Courses (AEC) including AECC and SEC, and Generic Elective (GE) Courses.

All courses are assigned specific course titles and course codes. Students must carefully fill in the correct codes and titles while submitting examination forms, as incorrect entries may lead to delay in the declaration of results.

### **Important Guidelines**

1. The CBCS system is applicable to old students of 2nd and 3rd Year.
2. The system follows an annual examination pattern.
3. Students must choose one stream, i.e. Arts or Commerce.
4. The curriculum includes:
  - Core Courses (CC)
  - Discipline Specific Elective (DSE)
  - Ability Enhancement Courses (AECC & SEC)
  - Generic Elective (GE)
5. Correct course codes and titles must be entered in the examination form.
6. A total of 132 credits is compulsory for obtaining the graduation degree.

### 13. Fine, Penalties and Leave Rules for students

1. No student is supposed to be absent without getting his/her leave sanctioned by the course teacher or Principal.
  2. Leave up to **6 days** shall be sanctioned by the concerned subject teacher.
  3. Leave more **than 6 (six) days** shall be sanctioned by the Principal. No leave will be granted during midterm examinations.
  4. Students who are officially deputed to participate in sports and co-curricular activities of the HP University Youth Festival are treated on leave for the purpose of attendance, provided that prior permission has been obtained from the Principal in this matter and its note has been made by the subject teacher in the attendance register.
  5. Students are required to get prior leave sanction in case they have to be absent from the college. The leave application must be countersigned by parents or guardians. In case of long sick leave a medical certificate is to be attached.
  6. The name of the student, who remains absent **for 6 days continuously** from any class, shall be struck off from the college rolls. However, the Principal at his discretion and after the recommendation from teacher concerned may re-admit such student on the payment of the readmission fee (which will be Rs. 100/- for first time and Rs. 200/- for second time). Such students must get re-admitted within 15 days from the date on which his/her name is struck off.
- Note:** A candidate whose name is struck off three times will not be re-admitted in the college.
7. In case of loss of **Identity-cum-library Card**, student will have to file an FIR in the Police Station and apply for issuance of duplicate Identity Card along with the copy of the FIR for which Rs. 20/- will be charged.

### 14. Evaluation System (CCA), MTT and Practical for B.A/ B.Com II, III

**Evaluation system:** As per H.P University guidelines, the marks scheme for all undergraduate courses in annual system for B.A/B.Com. programme will be in the ratio of 70:30 i.e. theory part (annual examination) 70 marks and internal assessment (IA)/ Continuous Comprehensive Assessment (CCA) of 30 marks.

The 30% marks of CCA will be awarded by the concerned teacher on the basis of the following components:

Mid Term Examination & Class test =15 marks

Assignment= 10 marks

Classroom Attendance = 5 marks

Total = 30 marks

**75% attendance in a course is compulsory as per H.P. University regulations. 5 marks of attendance will be awarded on the basis of following criteria:**

**Mid- Term Examinations:** A mid- term test/examination in each course will be held in the month of December in the academic year. It is mandatory for every student to appear in the mid- term test/ examination and the marks obtained shall contribute to the total CCA of 30%.As per university guidelines, the student has to obtain minimum 75% lecture attendance,

**Important Note:** In case a student fails to fulfill any of these conditions, he/she will not be allowed to appear in the final examinations.

## 15. College Library

Library caters to the need of students through its two fold service i.e the reading room and the issuance of books. It has a fairly good collection of books and has different sections for text books and reference books. The library subscribes to as many as five newspapers, four magazines including two specialized journals regularly. Students are encouraged to avail library facility during working hours in all working days.

### Library rules:

1. Library cum Identity card will be issued by the librarian within the 15 days of admission and every student is required to him/herself as a member of the library.
  2. Books are issued on the Library cum identity card, and the student must produce the card every time he/she visits the library.
  3. Only two books are issued at a time for 14 days. The librarian has the right to recall the books at any time.
  4. Reference books are not issued to the students.
    - i) In case of loss of a book, the student will have to replace the book or pay fine @20% extra in addition to the printed price of the book with the permission of the principal.
    - ii) The student is responsible for the book as soon as it is issued. In case a book is defaced/damaged in any way, the book is to be replaced by her/him.
- Schedule/time for issuance of book will be conveyed through notice.

## 18. Discipline & Code of Conduct

- Students are expected to strive for academic excellence through sincere dedication to their studies.
- Assignments, projects, and academic tasks must be completed diligently and submitted within the prescribed deadlines.
- Students are encouraged to seek guidance and make effective use of faculty support and academic resources whenever required.

### **Respect for Diversity**

- Every student must respect diversity and treat all individuals with dignity and equality.
- Discrimination or harassment on the basis of religion, caste, gender, race, language, or any other characteristic is strictly unacceptable.

### **Responsible Citizenship**

- Students are encouraged to contribute positively to the college community through participation in extracurricular activities, social service and community development programmes.
- Protection of the environment and proper care of college property are collective responsibilities of all students.

### **Compliance with College Policies**

- Students must remain familiar with all college policies, rules, and regulations and adhere to them sincerely.
- Violation of college rules may result in disciplinary action as deemed appropriate by the college authorities.

By adhering to this Code of Conduct, students demonstrate their commitment to academic excellence, personal integrity, discipline, and responsible citizenship as proud representatives of Government College Subathu.

## **19. Prohibition of Ragging Act, 2009**

Under the *Prohibition of Ragging Act, 2009*, “Ragging” means any act of disorderly conduct towards a student of an educational institution that causes or is likely to cause physical or psychological harm, fear, embarrassment, shame, or apprehension.

#### **Such acts include:**

- Teasing, abusing, or insulting a student
- Playing practical jokes that cause discomfort or humiliation
- Causing physical or mental harassment

- Forcing a student to perform any act that he or she would ordinarily be unwilling to do in any form is a punishable offence.

**A student found guilty of ragging may face:**

- Imprisonment for a term which may extend up to **three years**
- A fine which may extend up to **₹50,000/-**
- Or both

In addition, any student convicted of committing, abetting, participating in, or promoting ragging shall be:

- Dismissed from the college, and
- Debarred from seeking admission in any other educational institution for a period of **three years** from the date of dismissal.

Government College Subathu is committed to maintaining a safe, respectful and ragging-free campus environment for all students.
